## Water Testing – Manvers Lake

Two samples were taken from Manvers Lake, on behalf of Manvers Waterfront Boatclub, on the 22<sup>nd</sup> July 2021. The samples were submitted to SOCOTECs UKAS Accredited Microbiological Laboratory for analysis to determine Coliforms, E.Coli and Faecal (Intestinal) Enerococci.

The Analytical results were then compared against the Bathing Water Regulations 2013, based on the EC Bathing Water Directive 2006/7/EC. The limits, for both of these, are normally used for water that is tested on a regular basis, building up a statistical analysis over a number of samples, however the guidance values, illustrated below are still considered most appropriate for one-off or occasional testing.
